To Heather Rudy:

Reference is made to that certain Agreement for Services, effective July 17, 2023 (the "Agreement"), by and between Laramie County ("you" or "your") and EBenefits Solutions, LLC ("EBenefits").

EBenefits has entered into a Dissolution and Transfer Agreement with Businessolver.com, Inc. If we do not receive your consent by the Consent Date, please consider this written notice that EBenefits is providing you with Notice of Termination of the Agreement (for convenience) as required under Section 10.2 of the Agreement. Therefore, if consent to assign is not timely provided pursuant to this notice, the Agreement will terminate as of the close of business on January 21, 2025.
