WHEREAS, County and Contractor entered into a Food Service Contract, (the "Agreement") dated, November 20, 2012 for the management of the food service operation at the Laramie County Juvenile Service Center;

WHEREAS, County and Contractor amended the Agreement previously via an Amendment dated July 1, 2013, via Amendment No. 2 dated May 6, 2014, via Amendment No. 3 dated April 7, 2015, via Amendment No. 4 dated March 16, 2016, via Amendment No. 5 dated March 10, 2017; and via Amendment No. 6 dated March 12, 2018;

WHEREAS, County and Contractor desire to extend the term of the Agreement for one (1) additional year to cover the period from July 1, 2019 through June 30, 2020 ("Renewal Term");

WHEREAS, Section II, "Term" of the Agreement provides that after the initial contract period and ach subsequent year of the contract the parties may, by mutual consent, adjust the contract pricing based on the CPI (Consumer Price Index) Food Away From Home Index for the previous year;

NOW THEREFORE, the County and Contractor hereby agree to amend the Agreement as follows:

- 1. Renewal Term: County and Contractor agree to renew the term of the Agreement for one (1) additional year, effective July 1, 2019 through June 30, 2020.
