

**AMENDMENT TO LARAMIE COUNTY PUBLIC WORKS  
PROFESSIONAL SERVICES CONTRACTOR AGREEMENT  
LARAMIE COUNTY, WYOMING / TOP FLIGHT MAINTENANCE**

THIS AGREEMENT is made and entered into by and between Laramie County, Wyoming, P.O. Box 608, Cheyenne, Wyoming 82003-0608, (COUNTY) and Top Flight Maintenance, 1515 South Greeley Highway, Cheyenne, Wyoming 82007 (CONTRACTOR). The parties agree as follows:

**I. PURPOSE**

This Amendment shall constitute the first amendment to the Professional Services Contractor Agreement between Laramie County and Top Flight Maintenance, which was duly executed on May 2, 2023. The purpose of this Amendment is to provide for a one (1) year extension of the original agreement.

**II. TERM**

This Amendment shall commence on January 1, 2024, and shall remain in full force and effect until December 31, 2024.

**III. RELEVANT DOCUMENTS**

The documents which are part of this Amendment and Agreement between the parties, and to which this Amendment refers, are the following:

- A. This Amendment (3 pages)
- B. Professional Services Contractor Agreement, including all Attachments (51 pages)

**IV. RESPONSIBILITIES OF COUNTY**

COUNTY shall pay CONTRACTOR an amount not to exceed \$69,630.00, as stated in CONTRACTOR'S bid proposal, attached hereto and incorporated herein as Attachment 'B' of the original Agreement. Payment will be made upon receipt of the CONTRACTOR'S monthly invoice to the COUNTY. No payment shall be made before the last signature is affixed to this Agreement. Payments shall be in accordance with Wyo. Stat. § 16-6-602 (as amended).

**V. ADDITIONAL RESPONSIBILITIES OF CONTRACTOR**

- A. The CONTRACTOR shall not take on any additional duties as a result of this Amendment.

**VI. SPECIAL PROVISIONS**

- A. **Same Terms and Conditions.** With the exception of items explicitly delineated in the

Amendment, all terms and conditions of the Agreement between the COUNTY and CONTRACTOR, including but not limited to sovereign immunity, shall remain unchanged and in full force and effect.

## **VII. GENERAL PROVISIONS**

A. Entire Agreement: This Amendment, consisting of 3 pages, and the Original Agreement, consisting of 51 pages, represents the entire and integrated agreement and understanding between the parties and supersedes all prior negotiations, statements, representations and agreements, whether written or oral.

B. Addendum Controls: Where a conflict exists or arises between any provision or condition of this Addendum and the Agreement, the provisions and conditions set forth in this Addendum shall control.
