This Amendment No. 6 (the "Amendment"), is entered into this day of March, 2018 by and between Laramie County ("County") located at 310 W 19th Street, Suite 300, Cheyenne, Wyoming and Catering By Marlin's, Inc. d/b/a CBM Managed Services ("Contractor") located at 500 East 52nd Street, North, Sioux Falls, South Dakota.

WITNESSETH:

WHEREAS, County and Contractor entered into a Food Service Contract, (the "Agreement") dated, November 20, 2012 for the management of the food service operation at the Laramie County Juvenile Service Center;

WHEREAS, County and Contractor amended the Agreement previously via an Amendment dated July 1, 2013, via Amendment No. 2 dated May 6, 2014, via Amendment No. 3 dated April 7, 2015, via Amendment No. 4 dated March 16, 2016, and via Amendment No. 5 dated March 10, 2017;

WHEREAS, County and Contractor desire to extend the term of the Agreement for one (1) additional year to cover the period from July 1, 2018 through June 30, 2019 ("Renewal Term");

WHEREAS, Section II, "Term" of the Agreement provides that after the initial contract period and ach subsequent year of the contract the parties may, by mutual consent, adjust the contract pricing based on the CPI (Consumer Price Index) Food Away From Home Index for the previous year;

NOW THEREFORE, the County and Contractor hereby agree to amend the Agreement as follows:

The Foregoing recitals are deemed substantive and are incorporated herein as if fully set forth.

- 1. Renewal Term: County and Contractor agree to renew the term of the Agreement for one (1) additional year, effective July 1, 2018 through June 30, 2019.
- 2. <u>Cost per Meal</u>: County and Contractor agree to the following cost per meal to be effective during the renewal term:
