MEMORANDUM OF UNDERSTANDING BETWEEN THE LARAMIE COUNTY VETERAN'S TREATMENT COURT AND LARAMIE COUNTY, WYOMING.

This agreement is made and entered into this __ day of ____, 2018, by and between Laramie County, hereinafter referred to as COUNTY, and the Laramie County Veteran's Treatment Court, hereinafter referred to as VTC, both of Laramie County, State of Wyoming, witnesseth:

WHEREAS, each body, in performing governmental functions or in paying for the performance of governmental functions hereunder, shall make that performance or those payments from current revenues legally available to that party; and

WHEREAS, each governing body finds that the performance of this Agreement is in the best interests of both parties, that the undertaking will benefit the public, and that the division of costs fairly compensates the performing party for the services or functions under this agreement; and

WHEREAS, the COUNTY and VTC believe it to be in their best interests to partner for the purpose of providing expanded Veteran's Treatment Court services to Laramie County residents.

NOW THEREFORE, the COUNTY and VTC agree as follows:

Section 1.

If awarded, the COUNTY will receive, \$48,356.00 and the COUNTY will be the fiscal administrator of grant funds for the VTC.

Section 2.

The VTC agrees to use the award towards expanding the program's population, increasing drug and alcohol testing for program participants, and for the VTC team to attend the 2019 Justice for Vets conference in Washington D.C. This agreement is in effect until this grant program award no longer exists.

Section 3.

The VTC will be responsible for its own actions in providing services under the agreement and the COUNTY shall be the fiscal agent for the Department of Justice grant funds. The COUNTY will not be liable for any civil liability that may arise from the furnishing of the services by the other party.

Section 4.

The VTC agrees to provide the COUNTY with all requested reporting materials as is required under the grant award; in turn the COUNTY will fulfill all reporting requirements under the award term. Both parties will support efforts to adhere to the evidence-based program principles included in the NADCP Adult Drug Court Best Practice Standards and the ten key components.

Section 5.

The parties to this Agreement do not intend for any third party to obtain a right by virtue of this Agreement.

Section 6.

By entering into this Agreement, the parties do not intend to create any obligations express or implied other than those set out herein; further, this Agreement shall not create any rights in any party not a signatory hereto.

Section 7.

The COUNTY does not waive their Governmental/Sovereign Immunity, as provided by any applicable law including W.S. §1-39-101 et seq., by entering into this agreement. Further, the parties fully retain all immunities and defenses provided by law with regard to any action, whether in tort, contract or any other theory of law.
