Wyoming Department of Health County Prevention Grant Application Instructions

June, 2018

1. INTRODUCTION AND BACKGROUND

House Enrolled Act 62, Section 048, Footnote 7 of the 2018 Budget Session requires the Department of Health to provide grants to counties for prevention activities. The footnote reads:

7. Of this total appropriation, not less than eight million dollars (\$8,000,000.00) shall only be expended through unit 0550 to provide grants to counties for activities designed to prevent the use, misuse or abuse of tobacco, alcohol or controlled substances and activities designed to prevent suicide. Of this eight million dollars (\$8,000,000.00), not less than two million dollars (\$2,000,000.00) shall only be expended on grants to counties for suicide prevention.

Based on this requirement, the Wyoming Department of Health, Public Health Division (WDH-PHD) is accepting applications from Wyoming County Commissioners/Government for community-based public health prevention activities to address use, abuse, and associated negative consequences of tobacco, alcohol and controlled substances, as well as to provide suicide prevention services.

2. ELIGIBLE APPLICANTS

Wyoming County Governments.

3. FUNDING AVAILABLE AND NUMBER OF AWARDS

One (1) award is anticipated in each county. Eight million dollars (\$8,000,000) for Biennial Fiscal Year (BFY) 2019-20 is available. Each county will receive a base amount of one hundred fifty-five thousand dollars (\$155,000), plus two thousand, five hundred dollars (\$2,500) to conduct capacity enhancement activities. Remaining funds will be allocated based on county population.

4. TERM OF CONTRACT

The anticipated contract term for the County Prevention Grants are from July 1, 2018 through June 30, 2020. Option to renew the contract beyond June 30, 2020 will be at the discretion of the WDH-PHD and contingent upon funding from the federal government and the Legislature.

The chosen vendor will be expected to provide ongoing assistance to meet the general needs of every funded county's substance abuse prevention workforce and community coalition(s) in accomplishing prevention outcomes. Funding within the contract may also be used for further specialized and community specific technical assistance.

Technical assistance for suicide-specific prevention services will be provided by the Injury and Violence Prevention Program.

Pursuant to Footnote 7 to Section 048 of House Enrolled Act 62 from the 2018 Budget Session, the Wyoming Department of Health (WDH) is providing \$8,000,000 to counties for activities designed to prevent the use, misuse, or abuse of tobacco, alcohol, or controlled substances and activities designed to prevent suicide.

Funding will be allocated to counties as indicated on the table to the left. Each county will receive a base amount of \$155,000, plus \$2,500 to conduct capacity enhancement activities. Remaining funds will be allocated based on county population.

Funding (not including capacity enhancement and technical assistance) should be allocated by counties to meet the following priorities:

16%-26% - Adult binge drinking
18%-28% - Underage alcohol use
14%-24% - Tobacco prevention
4%-14% - Opioid/prescription drug and other drug
23%-33% - Suicide prevention

DEFINITIONS:

Capacity enhancement efforts are driven and funded by a federal grant, with the objective of enhancing infrastructure to implement effective community-level prevention activities. The Wyoming Department of Health has refined this definition to include seven (7) key areas for prevention:

- (1) Workforce: knowledge, skills, experience, social validity;
- (2) Resources: people, funding, space, time, access;
- (3) Effective communication: internal and external communication;
- (4) Community engagement: shared vision, diverse and inclusive representation;
- (5) Active leadership: involvement, commitment to prevention;
- (6) Readiness for change: community climate, history of effectiveness; and
- (7) Sustainability: buy-in, training.

Technical assistance for suicide-specific prevention services will be provided by the WDH Injury and Violence Prevention Program.

Technical assistance for substance abuse prevention activities, general coalition needs, or contractual obligations will be provided by the Substance Abuse Prevention Program, Tobacco Prevention and Control Program, and an outside vendor to be chosen through a collaborative procurement process. The chosen vendor will be expected to provide ongoing assistance to meet the general needs of every funded county's substance abuse prevention workforce and community coalition(s) in accomplishing prevention outcomes. Funding within each county's contract may also be used for further specialized and community-specific technical assistance.

 - The main coalition which will be leveraged to address priority areas of prevention will be the Healthier Laramie County Community Partnership (HLCCP). The HLCCP is a coalition of nearly 70 agencies dedicated to sharing resources, strengthening capacity, and collaboratively serving vulnerable residents of Laramie County. The HLCCP has for 20 years served as a convener to bring local organizations together, to focus effort and resources, and influence meaningful change in Laramie County. The HLCCP mobilizes "Action Teams" to address priority areas of concern identified by the community. Initiatives led by the HLCCP have addressed a wide range of issues including housing, access to healthcare, and wellness.

We additionally plan to collaborate with, and help facilitate the action planning of two other local coalitions commonly known as the Laramie County Coalition of Alcohol Problems and the Laramie County Tobacco and Wellness Coalition. We will also work in coordination with Grace for Two Brothers in the area of suicide prevention.

While the HLCCP is a private nonprofit organization, its board of directors contracts with Cheyenne Regional Medical Center to provide its executive leadership. The HLCCP does, however, maintain an independent board of directors responsible for governance and financial oversight. The main contact for the HLCCP is

We can at this time discuss in more detail other programs (in addition to the coalitions named above) to be leveraged with this funding. We do plan to build from existing efforts and available resources in order to maximize the impact of these dollars and maintain any gains which have been made to date.
