# PURCHASE AGREEMENT BETWEEN LARAMIE COUNTY, WYOMING & CATERPILLER INTERNATIONAL, INC.

THIS AGREEMENT is made and entered into by and between Laramie County, Wyoming, P.O. Box 608, Cheyenne, Wyoming 82003-0608, ("COUNTY") and Wyoming Machinery Company ("CATERPILLAR"). The parties agree as follows:

#### I. PURPOSE

The purpose of this Agreement is to provide for the purchase of three (3) new caterpillar 12M3 AWD BR motor graders by the Laramie County Public Works from CATERPILLAR as described in the attached Quote 212863-01 dated August 20, 2018. The Agreement of the parties includes this Agreement and the following documents, which are attached and incorporated herein by reference:

- Quote 212863-01 dated August 20, 2018 (Attachment A) (6 pages)
- Exhibit 1: Insurance Requirements for Vendors

In the event of a conflict in these documents, the terms of this Agreement shall control.

#### II. TERM

This Agreement shall commence on the date of the last signature affixed hereto and remain in full force and effect until terminated as provided herein.

#### III. PAYMENT

COUNTY shall pay CATERPILLAR upon receipt of an invoice to the COUNTY, or submission of other documentation certifying delivery of materials or other items, as indicated in Quote 212863-01 (Attachment A). No payment shall be made before the last signature is affixed to this Agreement. Payments shall be in accordance with Wyo. Stat. § 16-6-602 (as amended).

#### V. RESPONSIBILITIES OF CATERPILLAR

- A. CATERPILLAR shall provide the goods and services described in the attached documents (described in ¶ I. above), as modified by this Agreement.
- B. CATERPILLAR bears all responsibility for loss or damage to the products during shipment, and all responsibilities cease when the products are delivered to, and accepted by County.

#### VI. GENERAL PROVISIONS

A. Independent CONTRACTOR: Reserved

- B. <u>Acceptance Not Waiver</u>: COUNTY's acceptance or approval of the products furnished hereunder shall not in any way relieve CATERPILLAR of responsibility for its obligations hereunder. COUNTY's payment for any of the products shall not be construed to operate as a waiver of any rights under this Agreement or of any cause of action arising out of the performance of this Agreement.
- C. <u>Termination:</u> This Agreement may be terminated (a) by either party at any time for failure of the other party to comply with the terms and conditions of this agreement; (b) by COUNTY upon notice to CATERPILLAR, (c), by CATERPILLAR, with thirty (30) days' prior written notice to the other party; or (d) upon mutual written agreement by both parties.
- D. <u>Entire Agreement:</u> This Agreement (5 pages) and the documents listed in ¶ I. above, as modified by the Agreement, represent the entire and integrated agreement and understanding between the parties and supersede all prior negotiations, statements, representations and agreements, written or oral.
- E. <u>Assignment:</u> Neither this Agreement, nor any rights or obligations hereunder shall be assigned or delegated by a party without the prior written consent of the other party.
- F. <u>Modification:</u> This Agreement shall be modified only by a written agreement, duly executed by all parties hereto.
- G. <u>Invalidity</u>: If any provision of this Agreement is held invalid or unenforceable by any court of competent jurisdiction, or if the COUNTY is advised of any such actual or potential invalidity or unenforceability, such holding or advice shall not invalidate or render unenforceable any other provision hereof. It is the express intent of the parties that the provisions of this Agreement are fully severable.
- H. Applicable Law and Venue: The parties mutually understand and agree this Agreement shall be governed by and interpreted pursuant to the laws of the State of Wyoming. If any dispute arises between the parties from or concerning this Agreement or the subject matter hereof, any suit or proceeding at law or in equity shall be brought in the District Court of the State of Wyoming, First Judicial District, sitting at Cheyenne, Wyoming or the Federal District Court, District of Wyoming. The foregoing provisions of this paragraph are agreed by the parties to be a material inducement to CATERPILLAR and to COUNTY in executing this Agreement. This provision is not intended nor shall it be construed to waive COUNTY's governmental immunity as provided in this Agreement.
- I. <u>Contingencies:</u> CATERPILLAR certifies and warrants no gratuities, kick-backs or contingency fees were paid in connection with this Agreement, nor were any fees, commissions, gifts or other considerations made contingent upon the award of this Agreement.
- J. <u>Discrimination:</u> All parties agree they will not discriminate against any person who performs work under the terms and conditions of this Agreement because of race, color, gender, creed, handicapping condition, or national origin.

- K. <u>ADA Compliance</u>: All parties agree they will not discriminate against a qualified individual with disability, pursuant to a law as set forth in the Americans With Disabilities Act, P.L. 101-336, 42 U.S.C. § 12101, *et seq.*, as amended and/or any properly promulgated rules and regulations relating thereto.
- L. <u>Governmental/Sovereign Immunity:</u> COUNTY does not waive its Governmental/Sovereign Immunity, as provided by any applicable law including W.S. § 1-39-101 et seq., by entering into this Agreement. Further, COUNTY fully retains all immunities and defenses provided by law with regard to any action, whether in tort, contract or any other theory of law, based on this Agreement.
- M. <u>Indemnification:</u> To the fullest extent permitted by law, CATERPILLAR agrees to indemnify and hold harmless COUNTY, its elected and appointed officials, employees and volunteers from any and all liability for injuries, damages, claims, penalties, actions, demands or reasonable expenses arising from or in connection with negligent acts or omissions, willful misconduct, or defective products provided by CATERPILLAR pursuant to this Agreement except to the extent liability is caused by the sole negligence or willful misconduct of COUNTY or its employees. CATERPILLAR shall carry insurance and bonding sufficient to cover its obligations as indicated herein and is Exhibit 4 and provide COUNTY with proof of such insurance.
- N. <u>Third Parties:</u> The parties do not intend to create in any other individual or entity the status of third party beneficiary, and this Agreement shall not be construed so as to create such status. The rights, duties and obligations contained in this Agreement shall operate only between the parties to the Agreement, and shall inure solely to the benefit of the parties to this Agreement.
- O. <u>Conflict of Interest:</u> COUNTY and CATERPILLAR affirm, to their knowledge, no CATERPILLAR employee has any personal beneficial interest whatsoever in the agreement described herein. No staff member of CATERPILLAR, compensated either partially or wholly with funds from this Agreement, shall engage in any conduct or activity which would constitute a conflict of interest relative to this Agreement.
- P. <u>Force Majeure:</u> Neither party shall be liable to perform under this Agreement if such failure arises out of causes beyond control, and without the fault or the negligence of said party. Such causes may include, but are not restricted to, Act of God or the public enemy, fires, floods, epidemics, quarantine restrictions, freight embargoes, and unusually severe weather. In every case, however, a failure to perform must be beyond the control and without the fault or the negligence of said party.
- Q. <u>Limitation on Payment:</u> COUNTY's payment obligation is conditioned upon the availability of funds which are appropriated or allocated for the payment of this obligation. If funds are not allocated and available for the continuance of the services and equipment provided by CATERPILLAR the Agreement may be terminated by COUNTY at the end of the period for which funds are available. COUNTY shall notify CATERPILLAR at the earliest possible time of the services which will or may be effected by a shortage of funds. At the earliest possible time means at least thirty (30) days before the shortage will affect payment of claims, if COUNTY knows of the shortage at least thirty (30) days in advance. No penalty shall accrue to COUNTY in

the event this provision is exercised, and COUNTY shall not be obligated or liable for any future payments due or for any damages as a result of termination under this provision.

R. <u>Notices:</u> All notices required and permitted under this Agreement shall be deemed to have been given, if and when deposited in the U.S. Mail, properly stamped and addressed to the party for whom intended at such parties' address listed herein, or when personally delivered personally to such party. A party may change its address for notice hereunder by giving written notice to the other party.

RE: New Motor Graders

The Public Works Department recently solicited bid quotes for new AWD motor graders. We have reviewed the proposals against required specifications as well as new machine price, trade-in allowances and guaranteed buy-back values. It is our recommendation that Laramie County purchase (3) new Caterpillar 12M3 AWD BR motor graders from Wyoming Machinery for a total of \$841,366.47, minus a trade-in allowance of \$314,000 for (3) used motor graders for a grand total of \$527,366.47.
