Memorandum of Understanding

between

the Cheyenne Police Department, Laramie County Sheriff's Department, Office of the District Attorney of the First Judicial District, and Safehouse Services, Inc.

for

the Office on Violence Against Women Fiscal Year 2019 Improving Criminal Justice Responses to Sexual Assault, Domestic Violence, Dating Violence and Stalking Grant Application and Implementation

WHEREAS, the Cheyenne Police Department, the Laramie County Sheriff's Department, the Office of the District Attorney of the First Judicial District, and Safehouse Services, Inc., (hereinafter referred to as "partner agencies"), wish to collaborate in the submission of an application for an Office on Violence Against Women ("OVW") Fiscal Year 2019 Improving Criminal Justice Responses to Sexual Assault, Domestic Violence, Dating Violence and Stalking Grant (formerly known as Grants to Encourage Arrest Policies and Enforcement of Protection Orders Program) grant; and

WHEREAS, the partner agencies listed above have agreed to enter into this Memorandum of Understanding ("MOU") to memorialize their agreement that the Cheyenne Police Department will be the lead agency and the named applicant for the above-referenced grant, and that the other partner agencies will support and collaborate in the implementation of the grant, if awarded: and

WHEREAS, the application as prepared and approved by the above-named partner agencies is to be submitted to OVW on or before February 26th, 2019.

I. Description of Partner Agencies.

A. The Cheyenne Police Department is a progressive police agency of 107 sworn officers and 28 civilian staff dedicated to protecting and serving a community of 63,624. The

department offers varied officer assignments and civilian opportunities including Victims' Assistance for crime victims in the community. The Victim Assistance office and unit supervisor's office is located in the Cheyenne Police Department.

B. The Laramie County Sheriff's Department, located in downtown Cheyenne, Wyoming, has 83 deputies to protect and serve a rural population of 34,703 persons residing in an area of 2,688 square miles (6,962 km²). Created in 1867, the Laramie County Sheriff's Department exists to serve the needs of the public, employing a proactive approach to law enforcement. The Laramie County Sheriff's Department also provides Victim Assistance Services to assist crime victims in the county.

C. The Office of the District Attorney of the First Judicial District, located in downtown Cheyenne, Wyoming, prosecutes individuals that commit crimes within Laramie County, Wyoming, against residents and visitors. The Office of the District Attorney also includes a Victim Witness Program to support victims through the various procedural steps of a criminal prosecution.

D. Safehouse Services, Inc., is a Wyoming non-profit corporation that provides services for victims of domestic violence, dating violence, sexual assault and stalking. Since 1979, Safehouse Services, Inc., has been providing shelter, safety planning, protection orders, and other services for victims and their families residing in Laramie County, Wyoming.

II. History of Relationship.

A. Laramie County, Wyoming, has a collaborative relationship with all victim service agencies within Laramie County, including the partner agencies named in this MOU. The partner agencies to the MOU and other community service providers will work with and for

victims of domestic violence, dating violence, sexual assault, human trafficking, and protection order violations by meeting monthly to ensure quality services are being provided to victims, with safety being the number one priority.

B. The Cheyenne Police Department and the Laramie County Sheriff's Department work together with victim assistance on a daily basis by sharing information, when authorized by law, and by conducting joint investigations and operations. In the past, the two departments have successfully collaborated on a joint law enforcement computer information project and achieved the goal of a joint communications center. The departments also share the LERMS reporting program and MDT system.

C. The Cheyenne Police Department and the Office of the District Attorney of the First Judicial District currently collaborate in the prosecution of domestic violence, dating violence, sexual assault, human trafficking and protection order violation cases. The two agencies work together to prepare cases for trial, to locate witnesses, to secure the testimony of witnesses, and to maintain contact with victims after arrest and prior to trial.

D. The Cheyenne Police Department and Safehouse Services. Inc., have developed a professional working relationship. In 1996, the Cheyenne Police Department and Safehouse Services, Inc., collaborated on the initial Community Advocacy Response Initiative (CARI) domestic violence campaign. The initiative was very successful and facilitated communication on cases involving victims of domestic violence, dating violence, sexual assault, and stalking.

III. Development of Application.

In light of the notable increase in domestic violence incidents county-wide, the partner agencies to this MOU are committed to providing a continuum of services for crime victims

through the CARI program and through regular meetings with members of the Coordinated Community Response Team.

The partner agencies to this MOU assisted in the development of the grant application described above and have committed themselves to ensure a positive outcome. The Cheyenne Police Department took the lead on submitting the application with the other three partner agencies providing information and developing this MOU.

IV. Roles and Responsibilities.

- A. The Cheyenne Police Department and the Laramie County Sheriff's Department.
 - 1. The above listed city and county governmental agencies shall:
 - a. Provide CARI Unit patrol officers from the Cheyenne Police Department and the Laramie County Sheriff's Department to assist victims of domestic violence, dating violence, sexual assault, human trafficking, protection order violations, and stalking.
 - b. Ensure communications with all partner agencies by working closely with the Office of the District Attorney of the First Judicial District to provide evidence essential for prosecution.
 - c. Provide immediate response to service calls involving domestic violence, dating violence, sexual assault, human trafficking, protection order violations and stalking while operating in the capacity of a CARI Patrol Unit.
 - d. Collaborate with all partner agencies to this MOU through communication and collaboration from the CARI Unit Domestic Violence Detective from initial investigation through prosecution of offenders and provide

adequate and appropriate services for victims of domestic violence, dating violence, sexual assault, human trafficking, protection order violations, and stalking.

- e. The CARI Unit Domestic Violence Detective will conduct follow up investigation and utilize CARI Patrol Units and CARI Advocates to provide additional services to victims of domestic violence, dating violence, sexual assault, human trafficking, protection order violations, and stalking incidents reported during CARI Unit shifts.
- f. Provide the grant manager (unit supervisor) monthly statistical and demographic data regarding victims served with the operation of the CARI Unit to track the linkage of victims to advocacy services and CARI Unit referrals.
- g. Provide support, advocacy and assistance for victims throughout the criminal justice process.
- h. Provide additional services to victims as needed while on scene, including advising victims of procedures relating to the applications for protection orders.
- Upon request, provide training to the partner agencies to this MOU regarding domestic violence, dating violence, sexual assault, human trafficking, protection order violations and stalking upon request.
- j. Upon request, provide training to the partner agencies regarding the services provided by the Cheyenne Police Department and the Laramie County Sheriff's Department.

- k. Meet with other partner agencies to this MOU to discuss the effectiveness of the services provided to victims including facilitation of quarterly meetings with the CARI Unit.
- Act in a cooperative and collaborative manner with each partner agency to ensure successful implementation and operation of each program.
- m. Provide grant manager (unit supervisor) with monthly statements for reimbursement and pay sheets for the Officers and Victim Advocates of the CARI Unit.
- B. The Office of the District Attorney of the First Judicial District.
 - 1. The Office of the District Attorney of the First Judicial District shall:
 - a. Vigilantly prosecute cases of domestic violence, dating violence, sexual assault, human trafficking, protection order violations, and stalking that occur within Laramie County, Wyoming.
 - b. Communicate case status information to victims or victim advocates through the criminal justice process to ensure continued victim cooperation in the criminal justice process.
 - c. Provide the grant manager (unit supervisor) monthly statistical and demographic data regarding victims served by the CARI Unit to track the linkage of victims to advocacy services and CARI Unit referrals.
 - d. Upon request, provide training to the partner agencies to this MOU regarding domestic violence, dating violence, sexual assault, protection order violations, and stalking.

- e. Provide training to the partner agencies regarding the services provided by the Office of the District Attorney of the First Judicial District.
- f. Meet with the partner agencies to this MOU to discuss the effectiveness of services provided to victims, including attendance at meetings with the CARI Unit.
- g. Act in a cooperative and collaborative manner with each partner agency to this MOU to ensure successful implementation and operation of each program.

C. Safehouse Services. Inc.

1. Safehouse Services, Inc., shall:

- a. Maintain a twenty-four (24) hour, seven (7) day a week crisis line to provide information to callers regarding safety planning, services, and options available to victims.
- b. Provide to the grant manager (unit supervisor) monthly statistical and demographic data regarding victims served with the operation of this unit to track the linkage of victims to the advocacy services and CARI Unit referrals.
- c. Provide support, advocacy and assistance for victims throughout the criminal justice process.
- d. Provide additional services to victims that may include, but are not limited to, petitioning for Protection Orders, Sexual Assault Protection Orders and Stalking Orders, transportation, food assistance, financial assistance, housing, legal services, social service advocacy, and medical assistance.

- e. Work with the partner agencies to this MOU in a cooperative and collaborative manner, sharing information, when appropriate and permitted by law and the confidentiality policies of Safehouse Services, Inc., to ensure all the needs of the victims are being met.
- f. Upon request, provide training to partner agencies to this MOU regarding domestic violence.
- g. Provide training to the partner agencies regarding the services provided by Safehouse Services, Inc.
- h. Meet with partner agencies to this MOU to discuss effectiveness of the services provided to victims, including attending meetings with the CARI Unit.
- Act in a cooperative and collaborative manner with each agency to ensure successful implementation and operation of each program.

D. CARI Patrol Unit Advocates.

CARI Unit Advocates.

- a. Advocates wishing to apply for the CARI Unit need to have victim services and qualifications (1-year advocacy experience). Advocates applying from the Cheyenne Police Department, the Laramie County Sheriff's Department and Safehouse will be given preference when applying for the CARI Unit Advocate positions but not guaranteed employment.
- b. CARI Unit Advocates are required to complete and pass the department background process to include, drug screening, fingerprints,

background check and polygraph.

c. Any advocate applying for the CARI Unit Advocate positions must submit a letter of interest to the CARI Unit Supervisor, Leslie A. Burch. All CARI Unit Advocate applicants will participate in an interview process for the advocate position to be conducted by the CARI Unit Supervisor and the CARI Unit Advocate Supervisor.

d. In the event of termination or voluntary resignation of a CARI Unit Advocate, the CARI Unit Supervisor and the CARI Unit Advocate Supervisor shall participate in the replacement of position. (Please refer to the CARI Unit Policy and Procedure Manual, the Cheyenne Police Department Policy and Procedure Manual, and the City of Cheyenne Personnel Roles and Regulations for the hiring and termination procedures).

V. <u>Timeline</u>.

The roles and responsibilities described above are contingent on the Cheyenne Police Department receiving funds requested for the project described in the OVW FY 2019 grant application. Responsibilities under this MOU would coincide with the grant period, anticipated to be for 36 months beginning October 1, 2019 through September 30, 2022.

VI. Commitment to Partnership.

The collaboration service area includes Laramie County, Wyoming and all jurisdictions herein.

The partner agencies agree to collaborate and provide victim services and offender prosecution of domestic and dating violence, sexual assault, human trafficking, protection order

violations, and stalking for the benefit of the victims of these crimes pursuant to the program narrative of the grant application attached to this MOU.

Compensation for partner agencies' contributions to this project will be provided as outlined in the attached OVW budget detail worksheet.

The partner agencies, acting by and through their duly authorized representatives, have read and agree with this MOU, and have reviewed and approved the proposed grant application.

VII. General Provisions.

A. Amendments. Any party may request changes in this MOU. Any changes, modifications, revisions or amendments to this MOU which are mutually agreed upon among the partner agencies to this MOU shall become effective when incorporated into a written instrument, executed and signed by all partner agencies to this MOU.

B. Applicable Law. The construction, interpretation and enforcement of this MOU shall be governed by the laws of the state of Wyoming. The courts of the state of Wyoming shall have jurisdiction over any action arising out of this MOU and over the partner agencies, and the venue shall be the First Judicial District Court, Laramie County, Wyoming. The partner agencies intend and agree that the State of Wyoming, and the Office of the District Attorney for the First Judicial District, Laramie County, Wyoming, do not waive sovereign immunity by entering into this MOU, and specifically retain all immunities and defenses available to the State of Wyoming and the Office of the District Attorney for the First Judicial District as sovereigns pursuant to Wyoming Statute § 1-39-104(a) and all other state law.

C. <u>Entirety of Agreement</u>. This MOU, consisting of fourteen (14) pages, represents the entire and integrated agreement among the parties and supersedes all prior negotiations.

- D. <u>Prior Approval</u>. This MOU shall not be binding upon any of the partner agencies unless and until this MOU has been reduced to writing approved as to form by the City Attorney, the County Attorney, the District Attorney, and approved by the Board of County Commissioners of Laramie County, Wyoming, and the Governing Body of the City of
- E. <u>Severability</u>. Should any portion of this MOU be judicially determined to be illegal or unenforceable, the remainder of the MOU shall continue in full force and effect, and any party may re-negotiate the terms affected by the severance.
- F. Governmental Immunity. Except for enforcement of the terms and conditions of this MOU as between the parties, the City of Cheyenne, the Cheyenne Police Department, Laramie County, Wyoming, and the Laramie County Sheriff's Department do not waive their governmental immunity by entering into this MOU, and fully retain all immunities and defenses provided by law with respect to any action based on or occurring as a result of this MOU.
- G. Third Party Beneficiary Rights. The partner agencies do not intend to create in any other individual or entity the status of third-party beneficiary and this MOU shall not be construed so as to create such status. The rights, duties and obligations contained in this MOU shall operate only among the partner agencies to this MOU and shall insure solely to the benefit of them. The provisions of this MOU are intended only to assist the partner agencies in determining and performing their obligations under this MOU.
- H. <u>Interpretation</u>. Nothing in this MOU shall be interpreted or construed so as to authorize or compel any law enforcement or governmental entity or any other party to this MOU

to act in violation of any controlling state, federal or local law or regulation. It is recognized by the partner agencies that information gathered in the investigation, charging and prosecution of criminal offenses is privileged pursuant to law and cannot be communicated to individual or organizations not authorized to receive such information.

In witness whereof, the partner agencies to this MOU through their duly authorized representative have executed this MOU on the days and dates set out below, and certify that they have read, understood and agreed to the terms and conditions of this MOU as set forth herein.



BUDGET DETAIL WORKSHEET AND NARRATIVE

The Cheyenne Police Department in collaboration with the Laramie County Sheriff's Department, the Office of the District Attorney of the First Judicial District, and Safehouse Services Inc., request five hundred thousand dollars (\$500,000), from the Office on Violence Against Women (OVW), to fund the OVW Fiscal Year 2019 Improving Criminal Justice Response to Sexual Assault, Domestic Violence, Dating Violence and Stalking Grant Program. Funding would allow the continuation of our Community Advocacy Response Initiative (CARI) patrol units who respond to domestic violence, dating violence, sexual assault, human trafficking, stalking and protection order violations.

Personnel:

The award would compensate trained Cheyenne Police Department Law Enforcement Officers to respond and follow up on all domestic violence, dating violence, sexual assault, human trafficking, stalking and protection order violation calls for service during a CARI unit shift. Additionally, the Cheyenne Police Department Officers will work an average of twelve (12) hours per week overtime on the CARI Unit. Employed and experienced, full-time Advocates from the Cheyenne Police Department, the Laramie County Sheriff's Department and Safehouse Services Inc., will cover an average of twenty (20) hours per week split between the Cheyenne Police Department and the Laramie County Sheriff's Department. The CARI Unit Detective Sergeant of the Cheyenne Police Department will be supervising the CARI Patrol Officers and the CARI Unit Domestic Violence (DV) Detective position housed at the Cheyenne Police

Department. The CARI Unit DV Detective will follow up and investigate all domestic violence and dating violence cases, while being in direct communication with the Office of the District Attorney of the First Judicial District to gather any pertinent evidence further required for prosecution of the offender. Additionally, the CARI Unit DV Detective will follow up and investigate all sexual assault, human trafficking, stalking and protection order violation incidents that are reported during a scheduled CARI Unit shift. The CARI Unit DV Detective will also follow up with victims at the request of the Laramie County Sheriff's Department when contact with a victim cannot be established. The CARI Unit DV Detective will work closely with the CARI Unit Advocacy Supervisor who will maintain supervision over the CARI Unit Advocates and CARI Unit shifts. The CARI Unit Detective will report statistical data to the CARI Unit Advocacy Supervisor who will monitor grant reporting and the budget while documenting statistical information regarding calls for service. This position will also follow up on all domestic violence, dating violence, sexual assault, human trafficking, stalking and protection order violations. The CARI Unit DV Detective will begin January 2020 following approval of city council and finance committee approval and selection. This position is calculated for 2.75 years to accommodate this process.

The CAT team is a collaborative unit made of federal, state, county and city agencies who work specifically to combat human trafficking.

PROPOSAL ABSTRACT

The Cheyenne Police Department, the Laramie County Sheriff's Department, the Office of the District Attorney of the first Judicial District and Safehouse Services Inc., recognize that acts of domestic violence and dating violence, sexual assault, stalking and violation of protection orders are serious crimes that require the four aforementioned agencies to work in a cohesive and comprehensive, coordinated community response in Laramie County, Cheyenne, Wyoming. The four (4) partnering agencies desire to enter into a collaborative effort to provide a specialized patrol unit, Community Advocacy Response Initiative (CARI), who are trained in domestic violence and dating violence, sexual assault, human trafficking, stalking and protection order violations. Collaborating agencies are requesting "Arrest" funds to fully implement the initiative. The Cheyenne Police Department and the Laramie County Sheriff's Department have adopted pro-arrest policies and investigate these types of crimes to determine the primary aggressor, signs and symptoms of strangulation and diminish enforcement for acts of self-defense discouraging dual arrest, to enforce laws. Inquires of sexual assaults involve law enforcement investigation which includes a Sexual Assault Nurse Exam (SANE) conducted by a trained Forensic Nurse housed at Cheyenne Regional Medical Center who collects evidence while offering the options of the CARI patrol unit to respond to a sexual assault victim at the time of the report. Safehouse Services Inc. provides advocacy and services to victims of domestic violence and dating violence, sexual assault and stalking in a meaningful manner with victim safety a paramount consideration. This initiative will interlock the response of the law enforcement investigation and service implementation together to provide a more significant, timely and impacting experience for the victim; at the same time, this will focus on offender accountability. Investigations involving human trafficking includes law enforcement examination by the

Cheyenne Police Department Community Action Team (CAT)/ Human Trafficking Task Force which includes a multidisciplinary team response involving advocates, forensic nurses and prosecution. The Office of the District Attorney, First Judicial District believes in strong prosecution of domestic violence and dating violence offenders, sexual assault offenders, stalking offenders and offenders who violate protection orders and agree that a comprehensive coordinated response and thorough investigation is vital for victim safety and offender accountability. Providing a full-time CARI Unit Domestic Violence (DV) Detective at the Cheyenne Police Department who works directly with Cheyenne Police Department Victim Assistance Program and the Office of the District Attorney will maintain the goal of providing a safe and valuable experience for victims who report crimes to law enforcement while decreasing barriers in attitudes and social stigma that might keep victims from seeking out services; and at the same time holds the offenders accountable. This initiative will allow the CARI patrol units to make referrals to the F.E. Warren Air Force Base Domestic Abuse Victim Advocate and the Sexual Assault Prevention and Response Team for victim's serving in the military who live off base and within city or county jurisdiction. Funding for this project will train staff in the operation of every aspect of the CARI Unit, including victim interaction, direct services, primary aggressor and strangulation in domestic violence cases, sexual assault prevention, law enforcement investigations, integrating and coordinating sexual assault care, forensic nurse evidence collection, identifying human trafficking victims, coordinated community response, resources for victims who are immigrants, military agency options for victims and how the prosecution moves forward with cases while providing victim services throughout the court process. CARI unit forms, resource pamphlets and follow up cards will be provided to victims at the time of the reported incident.

- (ii) disclose, reveal, or release individual client information without the informed, written, reasonably time-limited consent of the person (or in the case of an unemancipated minor, the minor and the parent or guardian or in the case of legal incapacity, a court-appointed guardian) about whom information is sought, whether for this program or any other Federal, State, tribal, or territorial grant program, except that consent for release may not be given by the abuser of the minor, incapacitated person, or the abuser of the other parent of the minor.

If a minor or a person with a legally appointed guardian is permitted by law to receive services without the parent's or guardian's consent, the minor or person with a guardian may release information without additional consent.

(C) Release

If release of information described in subparagraph (B) is compelled by statutory or court mandate—

- (i) grantees and subgrantees shall make reasonable attempts to provide notice to victims affected by the disclosure of information; and
- (ii) grantees and subgrantees shall take steps necessary to protect the privacy and safety of the persons affected by the release of the information.

(D) Information sharing

- (i) Grantees and subgrantees may share-
- (I) nonpersonally identifying data in the aggregate regarding services to their clients and nonpersonally identifying demographic information in order to comply with Federal, State, tribal, or territorial reporting, evaluation, or data collection requirements;
- (II) court-generated information and law enforcement-generated information contained in secure, governmental registries for protection order enforcement purposes; and
- (III) law enforcement-generated and prosecution-generated information necessary for law enforcement and prosecution purposes.
- (ii) In no circumstances may-
- (I) an adult, youth, or child victim of domestic violence, dating violence, sexual assault, or stalking be required to provide a consent to release his or her personally identifying information as a condition of eligibility for the services provided by the grantee or subgrantee;
- (II) any personally identifying information be shared in order to comply with Federal, tribal, or State reporting, evaluation, or data collection requirements, whether for this program or any other Federal, tribal, or State grant program.

(E) Statutorily mandated reports of abuse or neglect

Nothing in this section prohibits a grantee or subgrantee from reporting suspected abuse or neglect, as those terms are defined and specifically mandated by the State or tribe involved.

(F) Oversight

Nothing in this paragraph shall prevent the Attorney General from disclosing grant activities authorized in this Act to the chairman and ranking members of the Committee on the Judiciary of the House of Representatives and the Committee on the Judiciary of the Senate exercising Congressional oversight authority. All disclosures shall protect confidentiality and omit personally identifying information, including location information about individuals.





Dear Director:

As Mayor of the City of Cheyenne, I submit this letter to certify to the following:

- the laws or official policies of the City of Cheyenne encourage, or mandate arrests of domestic violence offenders based on probable cause that an offense has been committed;
- the laws or official policies of the City of Cheyenne encourage, or mandate arrests of domestic violence offenders who violate the terms of a valid and outstanding protection order;
- 3) the laws, policies, or practices and the training programs of the City of Cheyenne discourage dual arrests of offender and victim;
- 4) the laws, policies, or practices of the City of Cheyenne prohibit issuance of mutual restraining orders of protection except in cases where both parties file a claim and the court makes detailed findings of fact indicating that both parties acted primarily as aggressors and that neither party acted primarily in selfdefense;

- 5) the laws, policies, and practices of the City of Cheyenne do not require, in connection with the prosecution of any misdemeanor or felony domestic violence, dating violence, sexual assault, or stalking offense, or in connection with the filing, issuance, registration, modification, enforcement, dismissal, or service of a protection order, or a petition for a protection order, to protect a victim of sexual assault, domestic violence, dating violence, or stalking, that the victim bear the costs associated with the filing of criminal charges against the offender, or the costs associated with the filing, issuance, registration, modification, enforcement, dismissal or service of a warrant, protection order, petition for a protection order, or witness subpoena, whether issued inside or outside the state, tribal, or local jurisdiction; and
- 6) the laws, policies or practices of the City of Cheyenne ensure that:
 - (A) no law enforcement officer, prosecuting officer or other government official shall ask or require an adult, youth, or child victim of a sex offense as defined under federal, tribal, state, territorial, or local law submit to a polygraph examination or other truth telling device as a condition for proceeding with the investigation of, trial of, or sentencing for such an offense; and
 - (B) the refusal of a victim to submit to an examination described in subparagraph (A) shall not prevent the investigation of, trial of, or sentencing for the offense.

- (C) follow-up tests for HIV as may be medically appropriate, and that as soon as practicable after each such test the results be made available in accordance with subparagraph (B).



FINANCIAL ACCOUNTING PRINCIPLE

- All funds awarded under this program will be maintained and accounted for separately
 and distinctly from other sources of revenue or funding. The Cheyenne Police
 Department and the City of Cheyenne follow policy and procedures to ensure funds will
 be tracked separately through generated Authorized Spending Reports, Payroll Registers,
 Proof of Payment documentation and a General Ledger.
- Formal written accounting policies and procedures have been developed and implemented and can be located at the Cheyenne Police Department. City of Cheyenne Purchasing Policies and Procedure manual is available at the City of Cheyenne Human Resources Department and available upon request. Revisions to these policies are done yearly or on an as needed basis.
- The financial management system can track actual expenditures and outlays with budgeted amounts for each grant or subgrant. Authorized Spending Reports are generated monthly to track all expenditures with the spreadsheet utilized by the Cheyenne Police Department Victim Assistance Program.
- The City of Cheyenne has a procedure in place for minimizing the time elapsing between
 transfer of funds from the United States Treasury and disbursement for project activities.
 The Cheyenne Police Department requests reimbursement of funds at the end of each
 quarter. Drawdown requests are typically submitted within 30 days of the end of the
 quarter.
- The Cheyenne Police Department has an effective internal controls in place to adequately safeguard grant assets and ensure that they are used solely for authorized purposed. The

Cheyenne Police Department requires approval by a supervisor prior to any expenditure. Staff submits purchase requests and justification to the supervisor. All expenditures are approved by the Chief or Captain and sent to the City of Cheyenne Treasurers Office. The City of Cheyenne Purchasing Policies and Procedures must be followed for all expenditures.

- The City of Cheyenne retains documented records for a minimum of five years and is audited annually by an independent auditor.
- The individual primarily responsible for fiscal and administrative oversight of grant awards is familiar with the applicable grant management rules, principles and regulations.



Community Advocacy Response Initiative (C.A.R.I.) Unit Advocate Position Description

Program Purpose:

It is the purpose of the Community Advocacy Response Initiative, domestic violence patrol unit, to take a systematic approach to addressing domestic violence, sexual assault, and stalking. In addition to gaining familiarity with the protocol, it will be necessary to adopt an attitude of zero tolerance for domestic violence, sexual assault, and stalking, thus insuring the CARI Unit provides safety for victims and accountability for perpetrators of these crimes. The CARI Unit contends that the protection of all victims of these crimes is its highest priority.

Specific Responsibilities of CARI Unit Advocate:

The following duty statements are illustrative of the essential functions of the job and do not include other non-essential or marginal duties that may be required:

- A. Immediate Response with patrol to domestic violence, sexual assault, human trafficking, stalking, protection order violation calls for service including any conflict between household members as defined by W.S. 35-21-202(iv): physical or verbal domestic violence, stalking, and violations of protection orders or criminal no-contact orders.
 - 1. Provide crisis intervention to victims and witnesses including children;
 - 2. Provide explanation of the dynamics of domestic violence and sexual assault, signs and symptoms of strangulation and human trafficking;
 - 3. Provide referral to collaborating agencies for emergency needs such as food, shelter, and clothing needs;
 - 4. Provide long-term planning options including safety plan information and explanation and completion of protection orders and other remedies to provide safety, the phone number for the district attorney's office and resources to local agencies and organizations;
 - 5. Provide notification of the victim bill of rights;
 - 6. Collaborate with officers in determining elements of the crime scene, including taking photographs, obtaining written statements, and information pertinent to determining dominant aggressor
 - 7. Complete necessary paperwork to ensure follow-up, including intake form with statistical information and lethality assessment, supplemental form, and shift duty response form and:
 - 8. Conduct follow up pictures at the request of the victim or CARI unit.
- B. During a scheduled overtime shift, the CARI Unit may provide further support to victims of domestic violence by providing the following:
 - 1. Extra patrol, a visible police presence to lend the victim feelings of security, as well as provide a deterrent to offenders;
 - 2. Provide follow-up to supporting agencies to hold offenders accountable, including verifying whereabouts for the court-ordered offender's group facilitators;
 - 3. Proactively monitor homes of victims for which a protection order is in place, and enforcing violations of such;

4. Contact victims without phones to notify them of court proceedings as provided by the victim bill of rights;

Qualifications: Advocates must be full-time employed advocates within the Cheyenne Police Department, Laramie County Sheriff's Department and/or Safehouse Services. Advocates must be sensitive and empathetic to people in a variety of crisis situations, have a valid Wyoming driver's license, be available by telephone when on-call, and able to work cooperatively with a wide assortment of people. At least (1) year of advocacy experience is preferred but not required. Academic degree and/or Professional Certification will be considered.

Special Requirements: Applicants must attach a letter of interest and resume with application. Must be willing to submit to a background investigation which includes a polygraph, fingerprints and drug test. Applicants will have no prior felony convictions. PROJECT NARRATIVE

Purpose of Application:

Laramie County is located in the southeast corner of the state of Wyoming. The county is comprised of 2,688 square miles, containing a population estimate from the United States 2017 Census of 98,327. Laramie County population has grown by 1.34% since 2017. Laramie County including the City of Cheyenne, added 1,322 people. The population estimate of Laramie County is 16.2% of the State of Wyoming, with 34 persons per square mile within the entire county. Estimates detail the City of Cheyenne houses 65.1% (64,019 – 2016 Census) of the population of Laramie County within 24.52 miles, bringing the amount of people per square mile to 2,425.1, 418 times the persons per square mile of the entire state of Wyoming.

In the past year, the Cheyenne Police Department and the Laramie County Sheriff's Department responded to 86,363 calls for service, of which 1,643 of these calls were domestic in nature, 159 were sexual assaults and 79 were stalking cases or protection order violations. Laramie County has continued to see an increase in business development with State, Government and Laramie County School District remaining the primary employers. F.E. Warren Air Force Base continues to be a major contribution to our population as it is the only air force military base within the State of Wyoming. There is also the influence of the Union Pacific Railroad and the Cheyenne Regional Medical Center. Laramie County has oil and gas activity within its borders and is in the center of two major interstates connecting to Colorado and Nebraska which influences the increase in population in the City of Cheyenne. Since Colorado has legalized the use of marijuana, drug trafficking has been a major obstacle for crime rate increases in Laramie County. In 2017, the NCBI found that marijuana use was positively and significantly associated with

psychological, physical, and sexual intimate partner violence perpetration. With this grant we would continue to address the rising issue of domestic and dating violence and reporting of sexual assault cases as our incidents are increasingly steady and more violent in behavior. A proactive approach towards responding, enforcing and prosecuting these crimes has been developed to address the increase of population related to the growing industries and businesses in the area.

In collaborating with our partner agencies; Safehouse Services Inc., Laramie County Sheriff's Department, the Office of the District Attorney First Judicial District, the Cheyenne Regional Medical Center Forensic Nursing Program (SANE), F.E. Warren Air Force Base Domestic Abuse Victim Advocate and the Sexual Assault Prevention and Response team, and the Cheyenne Police Department CAT/Human Trafficking Unit, we have detected specific areas that this grant will address and correct.

- Law enforcement lacks appropriate time to fully investigate crimes of domestic violence and dating violence, sexual assault, human trafficking, stalking and protection order violations and providing sufficient follow-up services for these cases.
- The Office of the District Attorney First Judicial District is overwhelmed with domestic
 violence and dating violence cases, strangulation, sexual assault, stalking, and protection
 order violation cases. Proper investigation and direct services are limited during the
 aftermath of the incidents being reported and during the court process.
- Persons identified as domestic violence victims by law enforcement are not seeking community services with Safehouse Services Inc. after the initial call for service despite prior knowledge of these community resources.

- Sexual assault and domestic violence victims who are military affiliated are not familiar
 or aware of the options located on base and identified as F.E. Warren Air Force Base
 Sexual Assault Response and Prevention team and the newly implemented Domestic
 Abuse Victim Advocate (DAVA).
- Sexual assault victims do not utilize the services of an advocate within the governing agencies and are unaware of what can be provided when a sexual assault is reported to law enforcement or through Cheyenne Regional Medical Center Forensic Nursing (SANE) program.

This project allows trained and qualified officers and victim advocates from the Chevenne Police Department, the Laramie County Sheriff's Department and Safehouse Services, Inc., to ride together, responding immediately to domestic/dating violence, strangulation, sexual assault, human trafficking, stalking and protection order violation related calls. All contracted victim advocates are required to complete and pass the required background check and follow the Cheyenne Police Department policies and procedure. This requirement reassures the advocates can access these cases and work in confidence with victims. This project provides an opportunity to strengthen our collaboration as well as a possible increase that the victim will follow through with referral opportunities and prosecution. The mission of the Community Advocacy Response Initiative (CARI) Unit is to respond to as many domestic/dating violence, sexual assault, strangulation, human trafficking, stalking and protection order violation calls and conduct as many follow-ups as possible, ensuring continued victim safety. The CARI program will complement Wyoming's STOP Violence against Women Implementation Plan by ensuring the victim's safety while encouraging arrests and enforcing the violations of the protection orders that have been granted by our court system. The project will complement the existing victim OVW FY 2019 Improving Criminal Justice Responses to Sexual Assault, Domestic Violence, Dating Violence and Stalking

service agencies within the communities by allowing dedicated services and contact with domestic violence victims outside of the realm of services that are provided daily. Specific and detailed dedication to these types of victims is something we cannot achieve with the multitude of other criminal acts that these victim service agencies handle on a daily basis. The impact of our current efforts to prevent and reduce these types of crimes in our jurisdictions is as follows:

The Cheyenne Police Department is a progressive agency of 107 sworn officers and 26 civilian employees, a total of 133 dedicated employees. The department serves the community with innovative policing and programs that contained specialized units. Of the 107 sworn officers, 83 are assigned to patrol duties which include responding to incidents of domestic violence, sexual assault, strangulation, human trafficking, stalking and protection order violations. There are approximately 739 persons per officer within the Cheyenne Police Department's jurisdiction; a ratio of 1.33, officers per 1,000 residents compared to the national average of 2.30 officers per 1,000 residents (Federal Bureau of Investigation). Officers are overwhelmed with the number of calls for service, and have the difficult task of responding, investigating, making appropriate legal decisions and clearing calls to move on to the next call. Rarely are officers able to complete any follow-up beyond their initial response and investigation. On a given day, there are 24 officers who handle the majority of the patrol calls (day shift-6, mids-shift-6, swing shift- 6, midnights-6, of which also includes a police supervisor). This number can be diminished when factoring in various leaves and trainings. Officers are assigned to geographical areas that have shown that these locations are up to three times more prevalent to have more incidents. Due to the high call volume, domestic violence cases can lack a thorough investigation. The Detective unit of the Cheyenne Police Department

is made up of 13 detectives who are assigned cases specific to property and people crimes. Currently, there is no detective assigned to investigate domestic violence cases or to provide follow up investigation after an arrest has been made.

- The Laramie County Sheriff's Department is one of the largest agencies of its type in the state of Wyoming and responded to 43,805 calls in 2018. The Laramie County Sheriff's Department to serves the needs of the public and is committed to an agenda of proactive law enforcement using planning and foresight to help solve the problems within the community. The Cheyenne Police Department and Laramie County Sheriff's Department law enforcement personnel work together daily by sharing information and conducting joint investigations and operations. In the past, the two departments have successfully collaborated on a joint law enforcement communication center, a DUI Mobile Command, SWAT and EOD teams. There are currently 55 deputies assigned to the patrol duties of rural Laramie County who respond to domestic/dating violence, sexual assault, strangulation, stalking and protection order calls for service. The ratio of deputies per 1,000 residents (not to include city residents) is 1.54, which is still below the national average.
- The Cheyenne Police Department Victim Assistance Program and Laramie County Sheriff's Department Victim Witness Program have five full-time advocates and one part-time advocate combined. The advocates contact victims and work all active cases within their respected departments. The advocates are on call 24-hours a day, seven days a week, and are dispatched to incidents at the discretion of a law enforcement officer. The Victim Assistance Programs work directly with detective units within their agencies; of

which part of their investigation duties is to follow-up on domestic/dating violence, sexual assault, strangulation, human trafficking, stalking and protection order violation incidents. Immediate victim contact is imperative following an incident to ensure victim safety and to give proper referrals for partnering agencies. When a victim is contacted, advocates immediately assess their safety and explain their rights as a victim while offering referrals to Safehouse Services Inc. The combined Victim Assistance Programs work closely with Safehouse Services Inc., for immediate shelter and protection order facilitation. Victims are also encouraged through a smooth transition from one agency to another and so that the victim will be fully informed of how the criminal justice process moves along with their respected incident.

The Office of the District Attorney of the First Judicial District prosecutes domestic violence, sexual assault, strangulation, human trafficking, stalking and protection order violation cases, occurring within Laramie County. Currently, the Office of the District Attorney is handling open and active cases exclusive to these types of incidents. Lack of proper investigation and regular contact with victims can cause prosecution to lose track of a victim which may in turn, result in the victim losing interest in suit? This grant will permit open communication between the Cheyenne Police Department and the Office of the District Attorney by providing a full-time CARI Unit DV Detective. The CARI Unit DV Detective will work directly with the prosecuting attorneys while delivering a thorough investigation, conducting follow-up visits with victims and arranging immediate services to victims through access of CARI Unit Advocates throughout the investigation and prosecution process.

- The Cheyenne Police Department has developed a multiagency Community Action Team (CAT) Human Trafficking Task Force. This specialized force will respond and follow up with incidents reported during CARI Unit calls involving human trafficking victims. The CAT Team will work directly with the CARI Unit Advocates to assess immediate needs. Training for the CARI Unit will be in conjunction with the CAT Team specific to the response of human trafficking victims.
- Safehouse Services Inc. is a non-profit agency dedicated to victims of domestic violence
 and dating violence, sexual assault and stalking. Services provided to their clients
 include, but are not limited to: crisis intervention, personal advocacy, financial assistance,
 emergency basic survival needs, shelter services to include transitional housing and
 emergency legal advocacy in assisting with filing protection orders.
- The Cheyenne Regional Medical Center Forensic Nursing Program (SANE) collaborates with our agencies on sexual assault cases investigated by law enforcement in providing medical assessment and sexual assault examination kits for sexual assault victims. Forensic (SANE) nurses are trained in collecting forensic evidence for strangulation and domestic violence cases. Law enforcement agencies can request supplemental evidence collection during follow up investigation processes. Additionally, Forensic (SANE) Nurses collaborate with victim advocates during the investigatory and medical examination processes and will work directly with the CARI Unit and the CARI Unit DV Detective.
- The F.E. Warren Air Force Base Sexual Assault Prevention and Response team and the Domestic Abuse Victim Advocate allot new avenues for victims who are military personnel and their dependents reporting sexual assaults and domestic violence. Services

will be available through military jurisdiction and CARI units will refer victims who live in city and county jurisdictions to the proper military affiliation for assistance.

Laramie County is the largest county in the state of Wyoming by population, but the 15th (of 23 counties) by area. Traditionally, Wyoming and Laramie County have been viewed as the home of the "Daddy of Em All" and Cheyenne Frontier Days. Laramie County enjoys a diverse population: 78.6% white non-Hispanic, 2.8% black, 1.2% American Indian or Alaska Native, 1.3% Asians, 0.1% Native Hawaiian and Other Pacific Islander, 2.9% persons reporting two or more races and 14.8% Hispanic or Latino. Laramie County is also home to a crossing of two interstates. Interstate 25 runs north and south through the county and Interstate 80 runs east and west. There usually is foreign traffic that crosses these two freeways as Wyoming attracts visitors traveling to Wyoming's National Parks from Denver International Airport (DIA), the area's largest international airport and 90 miles south on Interstate 25. At any given time, the population parameters and diversity can be altered by hundreds if not thousands.

While this project will address the needs of all the residents and visitors to Laramie County, we have discovered that those deemed as underserved would be those who do not speak English. We are fortunate to have bilingual officers and advocates available, as our Hispanic population has increased. However, with the influx of those traveling through our city from different races and ethnic background we can encounter language barriers. We have worked with Laramie County Community College and the University of Wyoming when we are in need of interpretation for foreign and rare languages and assistance for victims who are immigrants. We also feel that the physically disabled and elderly populations are other residents that could be classified as underserved. We consistently work with community partners in establishing

services or a gateway to services that would significantly benefit the physically disabled and elderly population in our community.

What Will Be Done:

Goal #1 – Immediate response to victims of domestic violence and dating violence, sexual assault, strangulation, human trafficking, stalking and protection order violations, to provide a thorough investigation of the incident and services to the victim(s) involved within the Laramie County limits.

Objective #1 – Employ Community Advocacy and Response Initiative (CARI) Units in block style varied shifts to respond to all initial calls for service involving domestic or dating violence, sexual assault, stalking and violation of protection orders during the 36-month grant term.

- CARI Units consist of a law enforcement officer and a victim advocate, both of
 whom are specially trained in the areas of domestic violence, dating violence,
 sexual assault, human trafficking, stalking, and the understanding and enforcing
 active protection orders.
- These units will ride and respond as a collaborative effort for investigation and offering community services to the victim. The advocate will remain in the marked police vehicle upon arrival at a dynamic scene until law enforcement secures the scene and clears the advocate to respond to the scene for safety of the advocate.
- Overtime shifts for the CARI Unit will be developed by each of the two law enforcement agencies (Cheyenne Police Department and the Laramie County

- Sheriff's Department), according to notable trends with the designated incident calls for service, by time of day and day of the week.
- CARI Unit officers and advocates will meet at the agency the shift is scheduled
 with to check a monitored daily communication log for any requested follow-up
 investigation or victim contact. A CARI unit will then be available for domestic
 violence and dating violence, sexual assault, human trafficking, stalking and
 protection order violation calls.
- CARI Unit will only respond to original calls specific to domestic and dating violence, sexual assault, strangulation, human trafficking, stalking, and protection order violations. They are not considered a marked unit available for all calls for service.
- CARI Unit officers will initiate an arrest of the appropriate offender of the
 incident in accordance with their training and experience in determining the
 primary aggressor of an incident or those in violation of protection orders, either
 by transporting the offender for incarceration or requesting a transport officer.
 Victim safety will never be compromised by clearing a scene prior to verifying
 the victim will be safe post incident.
- of where a victim made a choice to leave a domestic situation or where a sexual assault may have occurred. History and statistics support the claim that stalking tends to follow domestic or dating violence situations. CARI Units will drive by a victim's home or place of employment to pose as a deterrent to the offender.

CARI Units may stop by to see how a victim is doing, but victim safety will never by compromised by stopping unannounced.

- While at the location of the incident, advocates will speak directly with a victim, showing support and offering all the services that the victim is eligible for to include Crime Victim Compensation, to help defray any medical costs that may be associated with the incident. Advocates offer encouragement and explain the process that they may endure as the case progresses through the criminal justice system, set up follow-up appointments with the victim after regular office hours not to interfere with the victim's previously arranged schedules.
- CARI advocates will provide extensive case and follow-up information to ensure that CARI Unit DV Detective has all pertinent information for their case management.

Goal #2 – Provide follow-up services that the victim may require, as well as assist in any follow-up investigations as designated by CARI Officers, the CARI Unit DV Detective, Advocates or the Office of the District Attorney.

Objective #1 – Employ CARI Units in block style varied overtime shifts to follow-up on previously investigated domestic or dating violence, strangulation, sexual assault, human trafficking and protection order violations during the 36-month grant award term.

All collaborating partners, investigating detectives and non-CARI officers who
initially responded to a domestic or dating violence, strangulation, sexual assault,
stalking or protection order violation call will converse via telephone and/or email submitting a formal documented request for any follow-up investigations or

the specific need for the victim to be contacted. These requests will be maintained on a daily communication log designating that the previous incident requires follow-up services for the victim and further pertinent information for investigation of the incident, to include, but not limited to, follow-up injury photos, witness contact, pick-up written victim voluntary statements, to inform the victim of pending court information and/or the need for the victim to make contact with the prosecuting attorney.

- Follow-up calls may be requested twenty-four hours a day, seven days a week to be performed by the jurisdiction of which the original call for service commenced.
- Files will be retained at the associated law enforcement agency to document that follow-up was completed, what was done during the requested follow-up and should any other additional needs be present.

Goal #3 – Provide a full-time CARI Unit Domestic Violence (DV) Detective, from the Cheyenne Police Department Detective Unit.

Objective #1 – Employ a CARI Unit DV Detective to vigilantly investigate domestic violence cases and provide follow up investigation for the Office of the District Attorney while maintaining victim contact throughout the process of prosecution of the offender.

• The CARI Unit DV Detective will proactively investigate domestic violence and dating violence, strangulation, stalking and protection order violation cases. Additionally, any sexual assault or human trafficking incidents reported during a CARI Patrol Unit shift, the CARI Unit DV Detective will investigate these cases.

- The CARI DV Detective will initiate contact with victims to evaluate any further assistance the victim may require. The CARI Unit DV Detective will collaborate with law enforcement Victim Assistance Programs regarding victim contact information and completed follow up requests. Additionally, the CARI Unit DV Detective will meet with Safehouse Services once a week with the intent to connect with victims the agency may have lost contact with.
- The CARI Unit DV Detective will work and communicate directly with Office of
 the District Attorney to follow-up with the legal status of each case and assist in
 the process of prosecution. The CARI Unit DV Detective will meet with the
 prosecuting attorneys and provide follow up investigation requested for trial
 preparation.
- CARI Unit DV Detective will assist in statistical record keeping benefiting the CARI Unit when reviewing our progress for trends and for semi-annual progress reporting. The CARI Unit DV Detective will attend bi-weekly CCR Team meetings.

The CARI program makes a substantial impact on our community and the county as a whole. Providing immediate response to victim's needs, creating feasible safety plans and offering support systems, direct services and service providers that the victim may be encouraged to flee from the situation that made them a victim in the first place in invaluable. With law enforcement partnerships alongside our advocates, we can remove the offender from the situation creating the ability to completely focus on the victim. We expect an aggressive approach by the CARI Unit DV Detective to follow up on all domestic violence and dating violence cases, strangulation, stalking cases and violation of protection order cases to ensure that incidents do not slip through OVW FY 2019 Improving Criminal Justice Responses to Sexual Assault, Domestic Violence, Dating Violence and Stalking

the cracks. We feel that with consistent follow-up investigation and contact, it will show the victim that they are not alone, and that they are valued. Victims will see that community, from the law enforcement officer to the victim advocate and all the way throughout the process of investigation they are not alone.

Who Will Implement the Project:

Implementation will be done in a collaborative effort by staff members and employees of the Cheyenne Police Department, Laramie County Sheriff's Department, Safehouse Services Inc. and the Office of the District Attorney First Judicial District, including, but not limited to the following:

Cheyenne Police Department: Staff Project Oversight Lt. Rob Dafoe, will provide supervisory decision-making functions for the Cheyenne Police Department and the CARI Unit Domestic Violence (DV) Detective to ensure compliance with pro-arrest, dominant aggressor determination, thorough investigations and non-dual arrest by the department's officers selected for the CARI patrol unit. Sgt. Joel Hickerson will supervise and assign all domestic violence, dating violence, stalking and protection order violation cases to the CARI Unit DV Detective for follow-up investigation for prosecution and monitor a comprehensive investigation of said cases. Sgt. Hickerson will remain in direct contact with the CARI patrol unit as well as the prosecuting attorneys to ensure all vital information is gathered and evidence for prosecution is obtained. Sgt. Timothy Meyrick will be assigned to all human trafficking related calls for response, follow-up investigation for prosecution, assist in providing court notifications and perform comprehensive investigation of said cases. Sgt. Meyrick and the Community

Action Team (CAT) Human Trafficking Task Force will respond at the request of the CARI patrol unit for human trafficking calls.

- CARI Unit Advocate Supervisor: Leslie A. Burch, Cheyenne Police Department Victim Assistance Coordinator, will be responsible for supervising the CARI Unit Advocates. She will schedule officers and advocates to work the unit and submit semi-annual progress reports in the Grant Management System (GMS). Mrs. Burch will develop CARI Unit training for the partnering agencies. Mrs. Burch will oversee hiring, training and coordinating the CARI Unit advocates assigned to the CARI unit and will work directly with the CARI Unit DV Detective for follow-up requests. She will coordinate bi-weekly meetings for the MOU partners, and plan overtime sign-up schedules for both law enforcement agencies.
- Full-time CARI Unit Domestic Violence (DV) Detective: The full-time CARI Unit DV

 Detective will be responsible for pro-active investigation and follow-up contact to CARI

 Unit identified victims of domestic and dating violence, strangulation, stalking and
 protection order violations. Incidents reported during a CARI patrol unit shift involving
 sexual assault and human trafficking will be investigated by the CARI Unit DV

 Detective. Daily routine will include follow up investigations; contacting victims;
 coordinating with the Cheyenne Police Departments and Laramie County Sheriff's

 Department CARI Units; communicating directly with prosecuting attorneys, Safehouse
 Services Inc., Cheyenne Regional Medical Center Forensic (SANE) Nursing Program,
 military DAVA/SARC teams and the CAT team.
- Laramie County Sheriff's Department: Staff Project Oversight, Lieutenant (TBA) will
 facilitate communication and cooperation between agencies. The Lieutenant will provide

supervisory decision-making functions for the Laramie County Sheriff's Department and ensure compliance with pro-arrest, dominant aggressor determination investigations and non-dual arrest by the department's deputies selected for the CARI Unit. Detective Sgt. Curtis Burch will be the Sheriff's Department CARI unit contact person and will operate in the capacity of CARI Unit Supervisor. Sgt. Burch will be responsible for providing training to the law enforcement officers and advocates selected for the unit, along with Sgt. Hickerson, Sgt. Meyrick, the Office of the District Attorney, and Leslie A. Burch. Sgt. Burch will be responsible for making the monthly over-time schedule and collecting the Laramie County Sheriff's Department data, including investigation and arrest information for the reporting requirements of the project.

- Safehouse Services Inc.: Safehouse Services Inc. Executive Director Carla Thurin. Director Thurin will be responsible for providing advocates for the CARI patrol units and ensure that Safehouse Services Inc. services are available to victims of domestic violence and dating violence, sexual assault and stalking. Director Thurin will be the immediate supervisor and coordinating point of contact within the Safehouse Services Inc. agency for this project. Director Thurin has worked at Safehouse Services Inc. for over twenty years and is committed to assisting victims of domestic violence.
- CARI Advocates: CARI Advocates will be considered part-time, contracted employees of the Cheyenne Police Department, with the ability to work with the Laramie County Sheriff's Department deputies or City of Cheyenne Officers. Trained advocates will respond with a CARI Unit Officer to calls involving domestic and dating violence, sexual assault, strangulation, stalking and protection order violations and provide immediate intervention and advocacy services to victims and family members. Advocate safety is a

primary concern, they will have immediate contact with the victims after the CARI Unit Officer determines the environment is clear of any threats. Advocates will not leave the officer's presence during the response to the victim unless safety considerations have properly been discussed.

Currently all the collaborating partners on this project have a professional history of working together in a cohesive and comprehensive coordinated community response with a primary purpose to strengthen the collaboration between partners while addressing the needs of the community by improving access to resources and creating self-sufficient options for victims. Services are offered to victims daily, arrests are made, investigation proceeds, and the prosecution moves forward with their cases. The Cheyenne Police Department and the Laramie County Sheriff's Department are bound by their respected departments confidentially policy that was re-visited by a new mandate issued by the Federal Bureau of Investigation (FBI) and enforced by the Wyoming Division of Criminal Investigation. The policies control those that have access to criminal and case histories, as well as those that have access to specific parts of their respected departments. From simple conversations to record keeping, all information is kept from public view and media and is secured in locked cabinets. Case information is discussed with collaborative partners (CCR) and without any others present. The identity of anyone known as a victim of domestic or dating violence, sexual assault, strangulation, human trafficking and stalking will not be released to anyone outside of collaborative partners or for use other than the investigation and prosecution of the identified offender. Violators of this confidentiality will be removed from the program and with the new FBI mandate, could face further disciplinary actions. Safehouse Services Inc. is unable to release any information on clients that they serve

unless the victim signs a waiver on whom Safehouse Services Inc. may discuss their case with and under what circumstances, if any.

Sustainability:

The administration staffs at the Cheyenne Police Department, Laramie County Sheriff's Department, the Office of the District Attorney First Judicial District and Safehouse Services Inc., are committed to providing coordinated and consistent law enforcement and advocate response to victims of domestic/dating violence, strangulation, sexual assault, human trafficking, stalking and protection order violations after the grant funds are no longer available. The collaborative partners in this project will develop techniques while working with these victims. That hands-on training received is invaluable and through the course of this project will become a daily practice. While the funds may not be available to fully dedicate time and resources on victims of this crime type, the training that the advocates, officers, detectives, and prosecutors will gain from this program will remain in practice. Daily routines will be changed as a result of the training and specialized focus on victims and will continue from here on out. While the actual program name and title may not sustain without the assistance of these funds, the disciplines learned and practiced will be sustained. The Cheyenne Police Department values this program and will bring attention to the Cheyenne City Council meetings on the value for this program in the event that additional funds become available to the city of Cheyenne.
