**ENTITLED: “A RESOLUTION APPROVING THE PARSLEY BOULEVARD CORRIDOR PLAN.”**

**WHEREAS**, Parsley Boulevard is a collector roadway on the southeast edge of an original city in Cheyenne, Wyoming; and

**WHEREAS**, the Parsley Boulevard bridge over I-80 is programed to be reconstructed by WYDOT in 2022; and

**WHEREAS**, Parsley Boulevard is a narrow rural-road cross-section and needs a complete-streets design to enhance safety for all transportation users; and

**WHEREAS**, the Cheyenne Metropolitan Planning Organization (MPO) retained AVI p.c. on July 29, 2018 to develop the *Parsley Boulevard Corridor Plan*; and

**WHEREAS**, the project was guided by a steering committee comprised of the following agencies and organizations: WYDOT, the Cheyenne MPO, the City of Cheyenne Public Works, Planning and Engineering Departments, Laramie County Public Works, and the City of Cheyenne Board of Public Utilities; and

**WHEREAS**, the *Parsley Boulevard Corridor Study Plan* provides design criteria and recommendations for vehicular travel lanes, bicycle and pedestrian facility improvements,

**WHEREAS**, the *Parsley Boulevard Corridor Study Plan* provides a conceptual alignment for Parsley Boulevard from W. College Drive south to the Wallick Road section line,

**WHEREAS**, public involvement for the project consisted of two public open houses, (Oct. 24, 2018 and May 7, 2019) and on-line surveys using SurveyMonkey<sup>®</sup> to gather feedback on issues and recommendations; and

**WHEREAS**, the *Parsley Boulevard Corridor Study Plan* provides recommendations for three-lane section, curb and gutter, wider shoulders, lighting at major intersections and greenway or multi-use path throughout the corridor; and

**WHEREAS**, the Cheyenne MPO Technical and Citizens' Advisory Committees reviewed the *Parsley Boulevard Corridor Study Plan* and recommended adoption by the MPO Policy Committee; and

**WHEREAS**, the Laramie County Planning Commission held a public hearing on June 27, 2019, accepted public comments, and recommended that the Board of Laramie County Commissioners approve the *Parsley Boulevard Corridor Plan*.

**NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF CHEYENNE, WYOMING:**

**THAT**, the Laramie County Board of Commissioners hereby approves the "*Parsley Boulevard Plan*" dated June 4, 2019.

**FURTHERMORE, BE IT RESOLVED**, that the "*Parsley Boulevard Plan*" will be used as guidance for the future reconstruction of Parsley Blvd.
