BenchMark Engineers has reviewed the bids submitted on July 30, 2019 for the above-referenced project. Two bids were received for this project. Simon Contractors of Cheyenne submitted the lowest, responsible bid in the amount of \$ 1,459,377.49. All necessary documentation was included with the two bids submitted.

It is our recommendation that Laramie County accept the bid in the amount of \$ 1,459,377.49 from Simon Contractors. This work will include a full depth reclamation of the existing pavement and base material, cement stabilization of the reclaimed material, and paving North Yellowstone Road from approximately 0.3 miles north Bridger Drive through the intersections of Road 124A and Road 224, for a total length of approximately 2.74 miles.
