Thank you both for seeing David Jane's application through the appointment process. As I mentioned when I forwarded his application, the board has two more positions change due to the retirement of two members this month. Kathy Emmons of the Cheyenne / Laramie County Health Department and Lt. Eric Kent of the Laramie County Sheriff's Department will be replacing Gus Lopez and Michael Sorenson, with the approval of the city and county governing bodies.
