

TALLGRASS PONY EXPRESS PIPELINE, LLC

Tallgrass Carpenter Lateral Project

Tallgrass Pony Express Pipeline, LLC ("Tallgrass") is proposing to construct and operate an approximately 16-mile, 12" steel, crude oil pipeline in unincorporated Laramie County, WY, known as the Carpenter Lateral (the "Pipeline").

The overall Carpenter Lateral is comprised of 25 miles in Weld County, CO and Laramie County, WY and is an extension of the existing Pony Express Pipeline, which stretches about 830 miles from Guernsey, WY to Cushing, OK.

The Pipeline is proposed to originate near the center of Section 21, Township 14 North, Range 64 West, 6th P.M. (approximately 1.5 miles west of the TA Travel Center and the County Road 140 exit), then route easterly 3.5 miles across County Road 142, then turn south crossing under I-80 and continuing in a southerly direction, exiting Laramie County in Section 16, Township 12 North, Range 63 West, 6th P.M. (a map of the route is included in this letter).

Tallgrass is building the Pipeline to transport crude oil being produced in Laramie County and surrounding areas on to refineries in Kansas and Oklahoma and/or the Cushing, OK storage hub.

Currently, the construction of the pipeline is planned to commence in early 2020, with completion of construction and an in-service date expected in the Summer of 2020.


