ENTITLED: "A RESOLUTION TO RENAME ROAD J TO HR RANCH ROAD"

WHEREAS, Pursuant to WS §24-3-101 (a) the Board of Laramie County Commissioners request the initiation of the process changing the name of what is currently denoted as Road J, commencing at Prairie Center Circle, running thence south for 2,195' and terminating at HR Ranch Road, situated in the SE1/4 Section 28, Township 14N., R65W.; SW1/4, Section 27, Township 14N., Range 65W.; NE1/4, Section 34, T14N., Range 65W. of the 6th P.M. (See Exhibit A); and under **Resolution # 191001-12**, hereby requested the appointment of Dave Bumann, Laramie County Public Works Director as viewer to produce a report pursuant to WS §24-3-106 and return before the Board of County Commissioners to advise on the proposed alteration via name change of Road J to HR Ranch Road; and

WHEREAS, the Laramie County Public Works Director has viewed and evaluated the pertinent facts regarding the name change and recommends approval of the same; and

WHEREAS, the request for renaming Road J and HR Ranch Road is in the best interest of the public.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF LARAMIE COUNTY, STATE OF WYOMING, THAT:

1. The name of Road J be changed to HR Ranch Road, commencing at Prairie Center Circle, running thence south for 2,195' to where it meets with HR Ranch Road, situated in the SE1/4 Section 28, Township 14N., R65W.; SW1/4, Section 27, Township 14N., Range 65W.; NE1/4, Section 34, T14N., Range 65W. of the 6th P.M.
2. This segment of road will continue to have County maintenance.
3. A copy of this resolution and map shall be recorded in the Real Estate Division of the Office of the Laramie County Clerk, Ex-Officio Registrar of Deeds.






RE: Resolution 191001-12 – A Resolution Initiating Review Renaming Road J to HR Ranch Road

Commissioners,

This resolution requests renaming County Road J described as follows: Commencing from Prairie Centre Circle approximately 2,195 feet south and west terminating at HR Ranch Road, situated in the SE1/4 Section 28, Township 14N, Range 65W; SW1/4 Section 27, Township 14N, Range 65 W; NE1/4 Section 34, Township 14N, Range 65 W of the 6th P.M.. This section of roadway is currently developed as gravel, is County maintained and will remain so.

In discussions with County EMA, Planning & Development Department, as related to addressing procedures, as well as the Combined Communications Center, this would formally clear up any confusion or irregularities with addressing or dispatching emergency services to the area.

I see no adverse effects with this request and would recommend renaming the said portion of road to "HR Ranch Road" to remain contiguous with the current road segment.
