
PROJECT DESCRIPTION

Colorado Liberty Pipeline LLC (Liberty or applicant) is proposing to build, own, and operate the Liberty Pipeline (Project). This Project is an approximately 720-mile, 24 inch diameter crude oil/condensate pipeline. The Project will originate in Platte County, Wyoming near the town of Guernsey and traverse through Colorado and Kansas before terminating in Lincoln County, Oklahoma, near the town of Cushing. The majority of the pipeline route follows existing infrastructure corridors. Construction of the pipeline facilities will require use of both permanent and temporary right-of-way easements.

The portion of the Project that will be constructed in Laramie County is approximately 40 miles in length and will consist of 40 miles of 24-inch-diameter pipeline and one block valve. The Project centerline crosses into the north side of Laramie County from Goshen County roughly at MP 53.6, and travels south to MP 93.9 where it exits Laramie County and enters Weld County, Colorado. Attachment 2 contains a map of the Project in Laramie County, including a vicinity map and a detailed mapset depicting the proposed pipeline route. Construction of the Project will begin in the second quarter of 2020. The pipeline is proposed to be in-service by the first quarter of 2021.

Construction of the pipeline facilities will use both 50-foot permanent and 50-foot temporary easements. The two workspaces combined will comprise the 100-foot-wide construction right-of-way. During construction, additional temporary workspace (ATWS) areas alongside the permanent easement will be necessary to accommodate temporary storage of trench spoil; areas needed to string, weld, and install the pipeline; and movement and operation of construction equipment. ATWS areas may be required in areas of rocky soils; steep slopes; and rugged terrain; as well as for staging areas; truck turnarounds; utility crossovers; and utility, road, railroad, waterbody, and wetland crossings. The permanent easement will be actively maintained, free of trees and tall shrubs for the life of the Project.

Facilities appurtenant to the pipeline include block valves, cathodic protection, and pipeline markers. Block valves will typically be 50-foot by 50-foot graveled and fenced sites. In addition, magnesium anode beds and cathodic protection test stations will be installed. Cathodic protection test stations will be located outside the fenced valve sites spaced approximately every 1,000 to 1,500 feet and at foreign utility line crossings. These will typically be sited near road crossings and be similar of size to pipeline markers. Standard pipeline markers will be placed at road crossings and other locations to conform with applicable regulations enforced by the U.S. Department of Transportation, Pipeline and Hazardous Materials Safety Administration's Office of Pipeline Safety.
