The following nomination petitions for directors of Laramie County Weed & Pest Control District, Areas 3 and 7 were reviewed by the County Clerk's office for conformance with W.S. 11-5-104(a):

- Area 7: Dennis E. Hanson, 4949 Road 230, Albin, WY

Each nominee is a qualified elector in Laramie County, Wyoming, and each nomination petition contained the number of signatures of Laramie County landowners required under W.S. 11-5-104.
