FAA 2021 Grant Transfer to Northeast Regional Airport in the Amount of

\$351,485 to be Returned to Cheyenne Regional Airport in 2023.

The Cheyenne Regional Airport Board is a joint powers board comprised of appointees from both the City of Cheyenne and the County of Laramie. The Federal Aviation Administration (FAA) requires that both governing bodies, as well as the Cheyenne Regional Airport Board, approve Federal grants for Cheyenne Regional Airport . As such, attached for your review and consideration for approval is a Grant Transfer Agreement from the FAA which will allow Northeast Wyoming Regional Airport to complete a project in the summer of 2022. In return, Cheyenne Airport will have the money returned in 2023 for the second full phase of runway reconstruction.

Summary:

The Cheyenne Regional Airport will be issued a grant agreement for \$694,000 for AIP 059-2021 (Design Grant) leaving \$351,485.00 of available funds in the Cheyenne Runway Project balance. The FAA would like to schedule a transfer of 2021 grant funds for \$351,485 to the Northeast Wyoming Regional Airport to help them complete their 2021 AIP project. The Northeast Wyoming Regional Airport will be scheduled to repay the Cheyenne Regional Airport in FY 2022, and the funds will be available to the Cheyenne Regional Airport for the second phase of FY2023 runway reconstruction.

This is a routine practice between the FAA and various airports in Wyoming so that each airport can maintain construction and funding schedules to complete their projects.

Airport Staff will be present to answer any questions that may arise.
