CONSIDERATION OF A RESOLUTION AUTHORIZING THE RATIFIED SUBMISSION OF A GRANT APPLICATION TO THE DEPARTMENT OF JUSTICE FOR A FY2021 BULLET PROOF VEST GRANT IN THE AMOUNT OF \$11,276.34 WITH A 50% MATCH, ON BEHALF OF THE GOVERNING BODY OF LARAMIE COUNTY, WYOMING

FOR THE PURPOSE OF: REQUESTED FUNDS WILL BE USED TO PURCHASE 24 BULLET PROOF VESTS FOR THE LARAMIE COUNTY SHERIFF'S DEPARTMENT.

WITNESSETH

WHEREAS, the Governing Body of Laramie County desires to participate in the DEPARTMENT OF JUSTICE BULLET PROOF VEST PROGRAM grant by sponsoring this grant application to assist in financing this project; and

WHEREAS, the Governing Body of Laramie County has been provided with preliminary cost estimates and information on this project; and

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF LARAMIE COUNTY that a grant application in the amount of \$11,276.34 be submitted to the Department of Justice for consideration of assistance in funding the Laramie County Sheriff's Department, and that the County provides a 50% match (\$11,276.34) towards the purchase of 24 bulletproof vests.

BE IT FURTHER RESOLVED, that Sandra Newland, or her successor in the position of Laramie County Grants Manager, is appointed as agent of the Laramie County Board of Commissioners to execute and submit applications and certifications for these funds and to receive funds and implement the programs funded under this grant.
