

The Department of Homeland Security conducted a Facility Security Assessment of our election equipment storage in June of 2019. The assessment noted several commendable observations, including the use of security cameras and key card access. However, the assessment also identified potential security gaps in the County's basement where absentee ballots are processed. Their are currently no security cameras in this area to monitor absentee election processing. The county proposes to use grant funds to install

two security cameras in this space. We would like to collaborate with our existing security provider, VTI Security to add a 90 degree wall mounted camera and a 180 degree wall mounted camera. These cameras will provide wide angle coverage of room and entry for additional election security and monitoring. This equipment will help to ensure the integrity of upcoming elections.

Our project will provide physical security measures to increase the county's ability to ensure proper ballot processing, thus reducing vulnerabilities in the system. The physical security measures that we are taking with this project will ensure that absentee ballot processing and additional election work is protected and monitored. The installed security cameras will allow the county to monitor volunteers and employees for proper response and recovery associated with any threat related to elections.


