Paul Whalen, Planning, said the staff report and resolution condition #2 is amended to read: Developer shall provide a 30,000-gallon fire cistern at a location to be determined prior to recordation of the plat. Cistern shall be maintained by Fire District 2.

Mr. Whalen said AVI PC, on behalf of BBC Investments, LLC, submitted a Subdivision Permit and Plat application for Yellowstone Estates, located south of the intersection of Roads 124 and 224. This application proposes subdividing 351.4 acres from the existing 600-acre property and creating 60 residential-use tracts averaging 5.86 acres each.

Mr. Whalen said based on evidence provided, staff recommends approval with the adoption of findings of fact a and b with two conditions: 1. All agency comments regarding corrections shall be addressed prior to recordation of the plat and 2. Developer shall provide a 30,000-gallon fire cistern at a location to be determined prior to recordation of the plat. Cistern shall be maintained by Fire District 2.

Chairman Ash opened the hearing for PUBLIC COMMENT. Hearing no PUBLIC COMMENT, Chairman Ash closed the public hearing.

A motion was made by Vice Chairman Malm, seconded by Commissioner Thompson, to approve the Subdivision Permit and Plat for Yellowstone Estates with two conditions, and adopt the findings of facts a and b as stated in the staff report.

A motion was made by Vice Chairman Malm, seconded by Commissioner Holmes, to amend the main motion by changing condition #2 to the following wording:

2. Developer shall provide a 30,000-gallon fire cistern at a location to be determined prior to recordation of the plat, contingent upon the agreement that the cistern shall be maintained by Fire District 2.
