Report

Concentrated Feeding Operations Presentation

Brad Emmons, Planning, said the purpose of the public hearing is to discuss the option of using an odor footprint tool to regulate setbacks for Concentrated Animal Feeding Operations (CAFO) instead of a fixed setback. Mr. Emmons explained the odor footprint tool uses research data to derive a setback distance based on site location, type of livestock and facility, use of supplemental odor control, and terrain. Combining each attribute with an adopted annoyance factor results in a distance in all four directions that a facility must be set back from a number of different land uses. Mr. Emmons said there are advantages and disadvantages of using the tool as a setback requirement in Laramie County. He stated that the setbacks being discussed only apply to distances from occupied dwellings, public or private schools, and boundaries of municipalities. Distances from water wells permitted for domestic use, perennial streams, and static groundwater may exist. Mr. Emmons also noted any adopted regulations do not take into account items governed by DEQ such as air and water quality. A CAFO would still need to comply with DEQ regulations on these issues.

Mr. Emmons summarized the positive components of the odor footprint tool: 1) Collects data on odor emission numbers for some species of livestock, livestock facilities, manure handling facilities, odor control and terrain, 2) Considers weather data, including wind speed, temperature gradient, radiation, and topography, 3) Uses level of annoying odor, a faint odor that the average person may detect if attention was called to the smell, but would not change a person's behavior, 4) Provides a numerical distance based on the above factors, 5) Facility setbacks are based on size and type of operation, not a one-size-fits-all, and 6) Provides alternatives to design for the applicant, which may reduce odor and therefore setback. Mr. Emmons listed the negative component of the tool as: 1) Not all species of animal have been studied for an odor emission number, 2) The closest weather data is Alliance, NE, 3) Does not tell how far odor will travel, 4) Setbacks can change with varying factors, 5) Verifying the entered components and correlating them to the curve table, and 6) Does not account for extra area afforded the livestock (animal per square foot), only uses total size of the facility.

Mr. Emmons spoke of the advantages and disadvantages of a fixed distance. The positive components were: 1) Easy to measure and enforce, 2) Creates certainty regardless of situation, and 3) More closely matches state requirements by using a set distance. The disadvantage of a fixed distance is that all CAFOs have the same

setback, regardless of size and type of livestock.

Chairman Malm opened the hearing for PUBLIC COMMENT. Ron Butler and Elisa Butler, residents, spoke in favor of keeping the current regulations and against what they felt was the imperfect science of the order footprint tool. Brian Lovett, WY DEQ, clarified any change in land use regulations would still require the landowner to apply for a permit from the Water Quality Division. Jim Hastings, resident, expressed concerns about construction, odor, and property values. Jordan Evans, GIS, presented maps showing what a one, two, and three miles radius for 100 percent landowner consent would represent. Mr. Emmons explained state statute only addresses a one-mile radius for swine and the County's regulations are more stringent than state statutes. Hearing no further PUBLIC COMMENT, Chairman Malm closed the hearing.

A motion was made by Commissioner Thompson to set May 5, 2020, as the date for a decision on the odor footprint tool. After discussion and a recap from Chairman Malm on the history of the agenda item, Commissioner Thompson withdrew his motion.

The Board of County Commissioners directed Planning Staff to work with the County Attorney's office to provide options on land use regulations for CAFOs for the Board's consideration at its meeting on May 5, 2020. The options include the odor footprint tool and other alternatives, including amending the fixed setback distance from three miles to one.

A motion was made by Commissioner Thompson, seconded by Vice Chairman Holmes, that the Board make a decision on Laramie County land use regulations on concentrated animal feeding operations on May 5, 2020. The motion carried by the following vote:
