Mark Voss, County Attorney, requested the agenda item be continued to create language for a condition on the plat and to address issues related to public access to the subdivision and maintenance of the road, which is not a county road. He said the relationship between the easement granted to Laramie County across State land and access to the subdivision, as well as maintenance of the road, needed to be immortalized in the plat. Mr. Voss also said he wanted to see the grazing lease that affects ingress and egress through the subdivision.

Chris Lovas, AVI engineer and agent for the applicant, requested the board approve the item with an added condition so the project is not delayed. Mr. Lovas said he and the applicant will work with the County Attorney's office to create the correct wording on the plat.

Mr. Voss informed the board the issues involved were complex and had long-term legal consequences and additional time was required to draft conditions on the plat. He said his legal advice was for a two- to four-week delay. After further discussion, Mr. Lovas agreed to a two-week postponement to resolve the issues identified by Mr. Voss.

Further Business

17. Discussion on maintenance of Powderhouse Road to Ford Road.

Commissioners discussed whether the County should agree now to take responsibility for maintaining the 1300-feet of road between Powderhouse and Ford to be constructed in the Lone Star Estates subdivision.

Commissioner Thompson advocated for a policy decision by the board to agree to maintain the road because it will be a major thoroughfare and collector road in the future. Commissioners Holmes, Heath, and Lovett expressed concerns about setting a precedent. Commissioner Heath noted land use regulations should be clarified.

Chairman Malm requested an informal straw poll. Based on the poll, Commissioners agreed the developer will maintain the road in question until the road is dedicated as a public road. Direction was provided to County Attorney Voss to prepare the language on the plat conditions. Mr. Voss was also asked to outline the process for dedicating the portion of the road as a public road.

The meeting adjourned at 5:21 p.m.
